2021 Camp Covid Policy Agreement
Camp Staff Leaders and Chaperones

1. Each church is responsible to take and record the temperature of every person traveling to Seneca Lake Baptist Assembly for camp. Any person with a temperature greater than 100.4 F must not travel to SLBA.
2. Upon arrival at camp for registration, all persons temperature will be taken at a check point set up in the Lakeside parking area. Anyone with a temperature greater than 100.4 F will not be permitted to leave the vehicle. In the event of a commercial bus, temperature check will be in front of the dining hall.
3. Churches will be notified one week before camp where they will be assigned and if there is the possibility of adding any campers. If there is no space available in the assigned cabins/rooms, no last minute campers may be added. Every cabin or room must have a minimum of one chaperone per seven campers.
4. Churches are responsible to provide soap and paper towels for their cabins or rooms. Churches are requested to provide extra masks, hand sanitizer and a digital forehead thermometer with extra batteries. Chaperones are accountable to enforce mask wearing, hand washing, and social distancing for the campers assigned to them.
5. Cabin/room groupings, like family units, may travel together, participate in activities, and eat together without following social distancing policy. Distance between such groups must be a minimum of six feet. Mask wearing is absolutely required except when eating, swimming, walking outside with your group at least 6 feet from any other group, or while in assigned cabin/room with no visitors. Masks are required while hanging around outside any building or waiting in line.
6. Golf carts will be supplied with extra masks and hand sanitizer provided by SCBO representative. Except in an emergency or approved situation, no one is permitted to ride next to the golf cart driver.
7. Only one person per church will be permitted in the gym to register campers. This person is requested to bring all medications in small lunch bags with the campers name and church name already on the bag. Driver's may take the campers to their pre-assigned cabins/rooms rather than waiting in a vehicle at the gym area.
8. Camp t-shirts will be in zip lock bags with the camper's name and t-shirt size clearly visible. These bags will be in the assigned cabin/room with directions to check the size before opening the bag. T-shirts that have been taken out of the bags may not be traded for another size.
9. The camp nurse will take every persons temperature each time they visit the nurse's station. Chaperones are expected to take campers and chaperones temperature every morning and evening. Camp directors are expected to take camp staff temperatures twice a day. Designated staff may make random temperature checks.
10. In the event a staff person develops symptoms of Covid 19, they will return home. Parents of campers who had direct contact with that staff person will be informed, as well as those camper's pastor. In the event a camper develops symptoms, their parents will be contacted immediately by the camp nurse or SCBO representative. That camper's chaperone will inform their pastor and the parents of others campers in their group, ASAP.
